In comparison to the previous year, 2023 was a year of additional growth and renewal for NARSOL. General donations to NARSOL and its foundation performed handsomely and were significantly boosted by the generous bequeathal of a deceased member. The national conference in Houston was another huge success, and overall growth in membership was encouraging although, like many other organizations, NARSOL continues to struggle with member retention and renewal.

Enormous credit for the success of The Digest goes to a dedicated editorial team that volunteers countless hours of time writing and culling articles, gathering state reports, editing, proofing, and laying out the publication before it's sent off to the printers and prepared for bulk mailing (which includes a separate set of obstacles and challenges of its own).

NARSOL's strength lies in the justness of its cause combined with the devotion of its patrons. Its successful growth is a reflection of its character, which is dependent on the quality of leadership from top to bottom.

There are a lot of amazing people who work daily to keep this organization on an even keel. They are too numerous to name here. But we know who you are, and NARSOL is grateful for everything you do. Thank you.

#### **NEW BOARD MEMBERS**



## *revitalizing our* **DIGITAL REACH**

#### NARSOL ON THE WEB

One of the most exciting things that happened in 2023 is the re-vamping and re-opening of **NARSOL's resource site**. A host of volunteers divided up the sections and took responsibility for updating what was there and adding new entries. From the new **attorney database**, with many entries being NARSOL-member recommended, to **research documents and white-papers**; from a table of **important court decisions** to resources for **housing**, **crisis**, and **legal support**, every entry has been checked and links verified. Where applicable, the tables are categorized by state, and all are searchable by a variety of methods. This valuable resource is found at **resources.narsol.org**. Anyone is welcome to add new entries to any page.

We were also excited to launch our **brand-new website** with an entirely new look and feel. We have simplified and streamlined all the content, making it easier to locate helpful information. All of this work was done by dedicated volunteers who put in many hours to assure that every important page was kept and all information is still accessible to all.



#### COMMUNICATIONS

Communications was extremely busy in 2023. The most intense project was **helping with the re-vamp of NARSOL's resource site** with a major focus on gathering the names of attorneys for the attorney database. From soliciting attorney's names from our stakeholders and supporters, through verifying key elements of each of their practices, to determining the willingness of each attorney to be listed, this was a labor of love and one about which we continue to receive positive comments.

**One important communications role is assisting researchers and our state affiliates and representatives** in getting their messages out to the public. From surveys that will become part of a research study to announcements of victory in state affiliate legal actions, these communications are vital to our organization's outreach.

**NARSOL's blog** reflects the wide variety of topics important to our advocacy, including but not limited to: conference information; our court cases; civil commitment issues; media hype and misinformation; Halloween issues; scam warnings; joint projects with other advocacy organizations; federal marshals and compliance raids; and reaction to rare, horrific events. These blog posts are produced by a variety of writers, both inside and outside of NARSOL. Encouraging and soliciting guest writers will assure the future. Their pieces, used both in the blog and in the Digest, bring a new, fresh, and often personal perspective to our advocacy.

# growing our CONNECTIONS

#### **TEAMWORK!**


NARSOL supported the **Teamwork Makes the Dreamwork conference** in February in Washington, D.C. Organized by Women Against Registry, the conference brought together civil rights and anti-registry advocacy organizations and individuals from all over the country. **NARSOL board members Brenda Jones**, **Don Thurber**, **David Garlock**, and **Paul Shannon** attended as well as at least a dozen NARSOL representatives and members. **David Garlock** gave a presentation, and **Paul Shannon** represented NARSOL on a combined panel with WAR and ACSOL. Attendees visited elected representatives. The conference culminated in a dramatized vigil on the steps of the Supreme Court building highlighting the passing of the *Smith v. Doe* decision. The conference paves the way for continued collaboration between anti-registry organizations.

#### VOLUNTEERS

Volunteer participation in 2023 was markedly increased from 2022 by 16% even though one program was dropped in 2023 and others, such as participation on Twitter and Facebook, were reduced. The increase represents both new volunteers wanting to participate and existing volunteers becoming more involved with administrative and program endeavors.

New non-administrative volunteer participation in the Advisory Council, Fearless groups, and a more robust legal committee increased in 2023 participation over 2022. This was also evident in volunteer participation to redesign the NARSOL logo and website.

Additionally, there is no doubt that without the robust, invaluable participation of volunteers in the administrative matters of running NARSOL, from state contacts to regional coordinators to the board of directors, the organization would be hard pressed to be as responsive to our constituents and as effective in moving NARSOL's mission forward.



### *expanding our* **ADVOCACY & IMPACT**

#### **SCARLET LEGAL ACTION PROJECT**

In 2023 NARSOL responded to 129 legal requests for litigation. Each request is reviewed thoroughly by combing through both federal and state statutes and case law researching for viable claims. Emphasis is given to cases that would have a broad effect on large classes of registered or convicted people and cases that have a high probability of being successful.

In addition, NARSOL also responded to dozens of requests for legal assistance via telephone and email. While not all requests result in litigation, registrants are often guided to meaningful resolutions to their challenges. Individual registrants were removed from the registry in various states with our assistance in 2023. Prominent cases currently engaged in directly or indirectly in a supportive role are:

- WISCONSIN GPS MONITORING FOR LIFE This case challenges the constitutionality of a statutory scheme in Wisconsin which requires people convicted of certain sex offenses to wear a GPS monitor for life, even after they are no longer subject to any criminal supervision. Successful litigation would relieve hundreds of registrants from this burden. Antrim v. Carr, 19-cv-396 (Eastern District of Wisconsin)
- FORCED HALLOWEEN RESIDENCE SIGNAGE These cases challenge state laws in both Arizona and Missouri that allow law enforcement to place public warning signs at registrants' residences over the Halloween season. A court-imposed temporary restraining order has already been implemented while these cases move towards adjudication in 2024. Successful litigation would relieve all state registrants of this forced signage. Sanderson v Bailey, 4:23-cv-1242- JAR (Eastern District of Missouri) Wilcox v Alexander, 3:24-cv-03008-TLB (Western District of Arkansas)
- ILLINOIS DENIAL OF PRESCRIPTION MEDICATION This is a challenge to the state law that denies prescription ED medication to anyone convicted of a sexual crime. NARSOL et al. v. Hughes 24-cv-50025 (N. District of Illinois)
- NORTH CAROLINA PUNITIVE CHALLENGE TO REGISTRY This case argues that imposing additional registry requirements on persons formerly required to register is both punitive and in violation of ex post facto laws. It would relieve many of additional registry requirements. NARSOL et al. v Stein et al. No. 23-2040 (4th Circuit appeal from Middle District of N.C)
- OHIO LAW PROHIBITING PICTURES OF ANY MINOR Challenge to the state law that those convicted of a sexual offense against a minor "shall not possess a photograph of any minor child while the person is serving any prison term." Those found in possession of any picture of a minor in magazines, newspapers etc. are being prosecuted while incarcerated, delaying parole, and those living in the community face additional new charges. Successful litigation would relieve incarcerated Ohioans convicted of a sexual offense against a minor from this requirement.

#### **IN OUR STATES**

Eighteen of our state groups were active last year in their state legislatures, visiting lawmakers, submitting and testifying for or against relevant bills, assuring that registrant voices are heard, and educating by sharing facts. Several groups have built enough connections that they were able to introduce and campaign for bills that would change registry laws in their states for the better.

Many state groups continue to build connections in their communities as well, joining with other non-profit organizations to help move the needle not only for "our" constituency but also other justice-involved persons. Our affiliated/associated groups are also collaborating to build a combined messaging campaign targeting a much wider audience, in hope of finally influencing public opinion surrounding registries.

The groups are growing, as well! They are organizing and becoming 501c4s (for lobbying) or 501c3s (for tax exempt giving) and building or refreshing web sites. A new group, SHINE, comprised of women on the registry, has launched out of our Florida Action Committee and is making its presence felt. NARSOL created a new state associated group category, and six of our states have stepped up into this category.

In Connecticut, Arizona, and Florida, there have been recurring webinars and meetings for members and community guests with guest speakers, seeking to educate and correct the common narrative. There has been a return to more inperson dinners and picnics for members as well, building community and a sense of belonging.

Our Florida affiliate, the Florida Action Committee, spoke before the United Nations Human Rights committee in Geneva, Switzerland on harms of public registration and launched an anti-registry petition which has garnered over 6000 signatures.

We are seeing great outreach in many states, as evidenced by a plethora of activity, from "day to day" responses and assistance to registered persons needing guidance on maneuvering labyrinthine laws and navigating registry removal processes, to publishing handbooks, to sending holiday cards to persons incarcerated for sexual offenses. In Florida the FAC has been reaching out to everyone on sex offense probation by providing materials and invitations to mandatory treatment providers, sheriff's offices, and probation offices, while Iowans Unafraid has been sending letters to everyone on the registry letting them know they are not alone.

### *empowering one another* 2023 NARSOL CONFERENCE

#### **ANOTHER SUCCESSFUL GATHERING**



The 2023 conference opened on Friday, June 23, and ended at noon on Sunday, June 25. Our conference attendance was approximately 160 in person and 120 via the livestream.

Workshop topics included how registrants could successfully travel in our nation; writing op-eds; a virtual church where everyone, especially registrants, can successfully have their spiritual needs met; a civil commitment presentation; and a wide variety of other break-out sessions and workshops including a first-hand account by a mother and daughter about life with someone on the registry.

The first plenary speaker, journalist Steve Yoder, focused on how advocates could be successful in dealing with the media and using the media to help get our message out.

Speaker Alexa Sardina brought what is for many a new perspective, that of restorative justice (RJ) practices as a complete or partial alternative to criminal justice punishment. Alexa has a personal and refreshing approach to what it takes for healing to occur and be successful, both for the one harmed and the one who caused the harm. Speaker Adele Nicholas shared with the audience some of the cases she and her law partner, NARSOL board member Mark Weinberg, have worked on.






